Thank you for your call today informing us about your upcoming "Signs of Suicide" project with your high school students. We applaud your efforts at identifying and intervening with those students most at risk of suicidal ideation and intent. Early identification and intervention is crucial to preventing the catastrophe of suicide in our youth.

Foundations Behavioral Health Services can provide critical crisis intervention, assessment, and counseling services for St. Henry students and their families who are identified as needing professional assistance. We always have an on-call counselor and case manager who can respond immediately to urgent situations.

As a community mental health center, we offer a sliding fee scale based on monthly household income and household size. I have included our sliding fee scale for you to share with parents. We also accept Medicaid coverage as full fee for our services. In addition, many health insurance policies partially cover the costs of crisis intervention, assessment, and counseling services.
